#### **Entry Requirements**

#### Mandatory entry requirements:

- Students must obtain a clear police check and working with children's check to be eligible to complete the placement hours required.
- To attend placement, students are required to have three COVID-19 vaccinations as
  determined by the State Government on public health recommendations. Students are
  required to have the third COVID-19 vaccination by March 25th, 2022. Further information

#### Recommended entry requirements:

• Early Childhood services will not hire anyone under the age of 18. This information is relayed to prospective students during the enrolment process. Recommendation is that students should be a minimum 17 years of age to undertake the course.





#### Limitations to entry:

Inherent requirements for Early Childhood

- Physical activities: The work is likely to require a certain amount of physical activity, such as:
- Standing often for long periods of time
- Sitting down at a child's level
- Bending lifting and setting up play areas, changing nappies, making cots
- Walking supervising children in both the indoor and outdoor environments
- Heavy lifting (>15kg) sometimes lifting children or moving furniture
  - Providing a child safe environment, (being able to move quickly if a child is in danger)
  - Providing basic physical and emotional care for students (assisting with toileting and nappy changes/managing behaviour
  - Supervision of indoor and outdoor environment
  - Lifting of children, nappy changes etc.
  - Set up and put away materials both indoor and outdoor where required
  - Standing for long periods of time, being able to get down to a child's level and engage in activities which may be at a table or floor level
